I would like to object to the proposed development of building 150 homes on the field behind Cove Rangers stadium which I believe is known as Stationfields. My objections are:

- * The continuing growth of Cove means that facilities will be more stretched - shops, health care (surgery staff are already shared with Cove)
- * There will soon be no green spaces left. Deers still visit this field despite the recent culls in Tullos
- * The roads round Falkland Avenue are very narrow and can not be widened due to the boundaries of houses being on the road side
